Conditions of use

1. Your consent is valid until such time as you or your child inform us that you wish to withdraw your consent to the use of any of the images or videos for the purposes described. Where materials have already been produced and distributed we will ensure that for future publications images and or videos are removed within a reasonable timescale.
2. We may re-use photographs or recordings after your child leaves this school unless you withdraw your consent as detailed above.
3. We will not use the personal details beyond the use of full names and year group (which means first name and surname) of any child or adult in a photographic image on video, on our website, in our school prospectus or in any of our other printed, recorded or social media publications without requesting consent in advance. For example, we may include the full name of a student in a newsletter to parents if the student has won an award.
4. We will never include any personal contact details such as: e-mail, postal addresses or telephone numbers on any promotional material including video, on our website, in our school prospectus or in other printed publications.
5. We may include pictures of students and teachers that have been drawn, photographed or filmed by the students.
6. We may use group or class photographs, or footage where individual students are not identifiable.
7. Drawings, photographs and videos captured by students for the purpose of their studies will not be used externally to the school unless consent is expressly given. Exemplar work maybe retained for future use, within school and any names or personal details will be removed.
8. We may ask students without photo and media consent to withdraw from locations where photographs or videos are being taken for promotional purposes.

Please note that the press are exempt from aspects of the General Data Protection Regulation as agreed by the UK Government.
